

**ARROWHEAD AT VAIL ASSOCIATION  
BOARD OF DIRECTORS**

**RESOLUTION  
RELATING TO TRASH REMOVAL**

The Board of Directors of the Arrowhead at Vail Association, Inc., a Colorado nonprofit corporation (the "Association"), hereby approves and adopts the following Resolution:

**RECITALS:**

WHEREAS, the Second Amended and Restated Bylaws of Arrowhead at Vail Association (the "Bylaws") and the Declaration of Covenants, Conditions, Restrictions and Easements for Arrowhead at Vail (the "Declaration" give the Association the power to adopt rules regarding use of property within Arrowhead at Vail; and

WHEREAS, the Board and the Association wish to adopt rules concerning trash removal from property with Arrowhead at Vail.

**NOW, THEREFORE, BE IT RESOLVED:**

The Board of Directors of the Association, pursuant to Article VIII of the Declaration and Article VII of the Bylaws hereby adopts the following Trash Removal Rule [the "Rule(s)]:

**1. TRASH RESTRICTIONS.**

- a. All trash shall be placed in an animal resistant container.
- b. Trash containers shall be set out only on the day of scheduled trash removal service and returned to an enclosed area the same day. Any trash container place out at any other time may be returned to the residence by Arrowhead Public Safety or maintenance personnel, and the owner may be charged for the time of the personnel in performing this task. In addition, Public Safety or maintenance personnel may clean up any mess made out of an owner's trash by an animal, and the owner my be charged for the time of the Public Safety personnel in performing this task.
- c. All trash and containers must be screened from public view and protected from animals, wind or other disturbances except as allowed out on scheduled trash removal day.

**2. RESPONSIBLE PARTIES**

- a. The Property Owner is the sole party responsible for insuring compliance with the Rule(s).
- b. The Property Owner may not assign responsibility for compliance with the Rule(s) to a property manager, renter or any other agent.

**3. PENALTIES.**

- a. The provisions of the Rule(s) shall be enforced by the Association or its designated agent.
- b. Any violation of the provisions of the Rule(s) shall result in the following fines:

First Offense:	Warning
Second Offense:	\$200.00
Third Offense:	\$500.00 Fine
Subsequent Offenses:	Fines shall double for each subsequent offense

Imposition of any fine will be in accordance with the procedure set forth in Section 7.05 of the Bylaws.

This Trash Removal Rule shall go into effect thirty days from the date that this Resolution is certified. A copy of this Trash Removal Rule shall be mailed to each member of the Association prior to the effective date.


